

# Request for Proposal (RFP) for Bioethics Horizon Scanning for Mental Health Research

## 1. RFP Background & Objectives

## Summary

Pursuing mental health research gives rise to a myriad of ethics considerations and challenges. These range from the macro issues of setting priorities for MH research, to the appropriate design and review of different kinds of MH studies, to new questions emerging around novel technologies and experimental therapeutic options, as well as broad questions surrounding equity and respect in the investigations around pathophysiology/biopsychosocial drivers of MH and development and delivery of therapeutic interventions.

As Wellcome pursues an ambitious agenda in Mental Health to drive a step change in early intervention in anxiety, depression and psychosis—through research to improve **understanding** of aetiology & progression, develop effective **interventions**, and **stratify**/tailor therapeutic approaches—it will be important to proactively identify and attend to the inherent bioethics challenges in these research areas. This horizon scanning exercise will be the first step to map the wider range of MH bioethics challenges, and thus enable more in-depth bioethics research, analyses, and tool development that will advance the field.

#### **Objectives**

The MH Ethics Horizon Scan will provide a wide-ranging overview of key ethics issues that are central to advancing MH research addressing anxiety, depression, and psychosis. This should include issues that already present complexities in conducting studies on aetiology, pharmacological and non-pharmacological interventions, as well as those issues most likely to arise with novel approaches being pursued in the mental health space.

The key outputs will include:

- Identification and classification of key ethics issues relevant to MH research addressing anxiety, depression, and psychosis
  - o Classification could include: relevance to areas of the MH portfolio (understanding, stratification, intervention); primary ethics issue(s); maturity of the issue (longstanding, current/new, emerging/future); salience and importance to people with lived experience, etc.
- Summary of current norms, frameworks, resources that exist in practice/the literature (or analogous resources from other areas of health research that may attend to or be easily adapted to the MH research space)
- Identification of issues where there are significant gaps, barriers, and/or major areas of contention in how to attend to ethical complexities in MH research. Identification of issues of the most importance to people with lived experience, and lived experience perspectives on the literature around these issues
- A prioritisation matrix that will enable identification of most urgent and important areas of bioethics research to support MH



The outcome will be a comprehensive stock-taking exercise that will enable Wellcome's MH and RE teams to prioritise future funds in developing a portfolio of bioethics work that attends to areas central to the mission of the MH health challenge area.

# 2. RFP Specification

## **Scope and Exclusions**

The horizon scanning of bioethics issues in mental health research should align with the focus on the Mental Health challenge area, and therefore be limited to those that facilitate a step change in earlier and more effective intervention in anxiety, depression, and psychosis. While these conditions 1[1] are broadly defined (and include OCD, PTSD, schizophrenia, bipolar disorder, and post-partum psychosis), issues specifically arising in research on other mental health conditions should not be included in this horizon scan (e.g., substance misuse and addiction, eating disorders, neurodevelopmental disorders)

Some broad categories regarding the kinds of bioethics issues that this horizon scanning exercise should surface include (but are not limited to):

- Classic ethics issues related to the conduct of clinical research that have unique complexities or particularly nuanced considerations in the context of mental health research. For example:
  - o Issues related to autonomy, respect for persons, and self-determination interests, including in study inclusion/exclusion criteria, consent processes, and handling of acute states of mental ill health that arise during the conduct of the research study
  - Fair subject selection, equity/bias in sampling and enrolment, disaggregated reporting of findings
  - o Privacy, confidentiality, and protection against stigma
  - o Post-trial access and scalability of novel interventions
  - o Research with paediatric and adolescent populations
- Issues related to mental health research prioritisation and design
  - e.g., approaches to involving people with lived experience in agenda setting, prioritisation, and study design

<sup>1</sup> We recognise that there are a variety of terms to refer to mental ill health as well as specific conditions or mental states. For the purposes of this document, we have adopted "mental health conditions" as a way of being inclusive of perspectives that may not adopt or favour biomedical explanatory models or terminology. We also recognise that search terms used to conduct the bioethics horizon scanning may necessarily include the wider range of terminology that some may medicalising or stigmatising. We encourage suppliers be thoughtful about how they plan to use contested terms in the information gathering stages as well as in framing the bioethics issues in the final deliverables.



- Issues specific to studies on aetiology, pathophysiology, and biopsychosocial drivers. For example:
  - o Issues arising with new neuroimaging techniques, genetic and epigenetic studies, and other biomarkers or predictors of mental ill health
  - o Links between infectious diseases and anxiety, depression, or psychosis; the role of the microbiome; the role of inflammation
  - o Equitable study accounting for sex differences/life-course approaches (e.g., role of hormonal changes and onset/course of MH conditions); intersectional approaches to understanding pathogenesis and progression
  - o Implications of identifying and disclosing risk factors for future mental illness for identity, relationships, and other potential psychosocial harms
- Issues specific to interventional studies and therapeutic approaches, including:
  - New technologies (e.g., brain stimulation therapies & implants, VR-based CBT, chatbots); Psychedelics and alternative substances
  - o Potential challenges with stratification, differentiated care pathways, personalised medicine
  - Scalability & equitable access and uptake of interventions in the pipeline, in light of health system constraints and provider supply issues, including lack of diversity among providers
  - o Discontinuation of pharmacological interventions

#### **Deliverables and Timelines**

- A broad cataloguing of bioethics issues related to MH research on anxiety, depression & psychosis, with key research questions outlined and highlights of any existing research, frameworks or tools that address the issue (9 months).
- An interim report on findings, including emerging and/or salient high-priority areas for further bioethics research. (5 months)
- A matrix tool of the issues that highlights critical areas for further bioethics research based on urgency, importance, current gaps, conceptual debate, expressed views of people with lived experience, and other relevant factors (preliminary review of tool at 5 months; final populated tool at 9 months)
- A high-level summary document and/or graphics to communicate findings with internal and external audiences (9 months)

The work will cover a period of up to nine months, though we are happy to consider shorter timelines.

## **Details requested in the Proposal**

- Detailed methodology outlining the approach for surfacing bioethics issues from relevant information sources (e.g., literature, meetings & conferences, clinical trial registries, provider and patient networks, social media, expert consults, etc.) and proposed approach to organising issues by sub-themes
- A proposed set of priority-setting criteria and plans for assessing surfaced bioethics issues against those criteria



- A proposed plan of how people with lived experience will be involved in the design, delivery and governance of this project
- Details on how you plan to address issues of bias and inequity in many existing data sources, including how you plan to include perspectives of minoritised groups and experience from LMICs
- A breakdown of costs, including the estimated time required to complete the deliverables

All deliverables must be made available under the Creative Commons Attribution licence (CC-BY).

Suppliers should request the appropriate budget needed to deliver the required outputs over a period of 9 months. Payments will be linked to deliverables which will be agreed with the supplier.

Involvement of lived experience is considered an essential part of Wellcome-funded projects, and we would expect our Supplier to embed people with lived experience expertise of anxiety, depression or psychosis in the design, implementation and/or dissemination of the work<sup>2</sup>.

## **Expression of Interest**

Suppliers are asked to send in a short expression of their intent to submit a proposal by e-mail to the Wellcome Contact in accordance with the RFP timetable. Please include:

- Confirming whether you are a company or individual, if company please provide full company name, address, and company registration number.
- A non-binding cost estimate as a single figure in GBP.

The date provided for this 'expression of interest' is suggested to aid in our planning purposes, but those who miss this date may still provide a note of interest and submit a full proposal. However, any questions must be submitted by the deadline in the RFP timetable.

## **Supplier Q&A**

Prior to the submission of your RFP response, Suppliers are provided the opportunity to submit any questions they have about the exercise and the activity. All questions will be collated, anonymised, answered and returned to all Suppliers who have submitted an expression of interest in the RFP process as well as posted online. Please make sure you ask all questions at this stage. Once Wellcome have responded to all questions if you have any additional questions after this deadline these will not be answered to ensure that this is a fair and equitable process.
