1.	<p><b>File Format:</b> The RFP requires that the resources are collated in a user-friendly repository - what <b>file format</b> do you have in mind? Would these be Word documents?</p>	<p>Wellcome anticipates that the document format will be either Word Document or PDF, and the most important aspect will be that it meets the accessibility requirements.</p> <p>All our content should be WCAG 2.2. AAA compliant. Any documents being provided to Wellcome must pass accessibility requirements. An example of an accessible document you've produced must be provided in your response as outlined in the RFP. Please note that documents, such as PDFs, must be tagged, have a logical reading order assigned, be bookmarked, include suitable alt-text for any images, have the default language set and meet colour contrast standards.</p> <p>A thorough review for accessibility of the document must take place before delivery to Wellcome. However, we would encourage the supplier to think about how they plan to undertake this work and what this would look like in terms of timelines. We would anticipate that the supplier outlines the milestones and build these into the project plan, linked to the deliverables suggested. <p>5.</p>	<p><b>Barriers and challenges:</b>            The RFP introduces the landscaping report (p. 1 of the RFP) as needing to: “focus on the <b>tools</b> needed to help our researchers embed engagement in Wellcome-funded research and the <b>barriers and challenges</b> that researchers currently face in undertaking this work”. However, in the four detailed objectives outlined for the landscaping report on p. 2 the barriers are not mentioned under any of the four bullet points. Could you please clarify what the focus of the landscaping report be when it comes to current barriers and challenges? Should they be included under one of the four bullet points and if so which one? Should they be included separately or as part of a scene setting piece? How much weight should be given to the barriers and challenges compared to the other objectives?</p> <p>Given the objective to identify tools that can embed cross-sectoral stakeholder engagement within Wellcome funded research and overcome barriers, would it be possible to share the existing challenges to such approaches that have been identified so far, within existing research?</p>	<p>The landscaping report will be primarily focused on the tools available to researchers. Wellcome anticipates that during the research on the landscaping report, barriers and challenges to how researchers can use these would be frequent and form an essential part of the report's narrative. Wellcome will not be able to share existing research on this point.</p> <p>Wellcome is open to the barriers and challenges being integrated into the landscaping report at the supplier's discretion as long as it has been considered. This could entail including it as a bullet point or as a core part of the scene-setting piece.</p> <p>Wellcome anticipates that this will form part of the proposed methodology or approach to undertaking this work and may be part of the research questions. Supplier due diligence checks are completed during shortlisting and contract negotiations.</p> <p>Standard terms and conditions are linked in the RFP for registered companies, individuals submitting a proposal as a sole trader, or an individual contracting through their own personal services company. We don't have a preference but ask that a proposal makes clear the organisation/ individual submitting the proposal.</p> <p>Wellcome does not have any restrictions regarding location for research activities apart from sanctioned countries.</p>
